

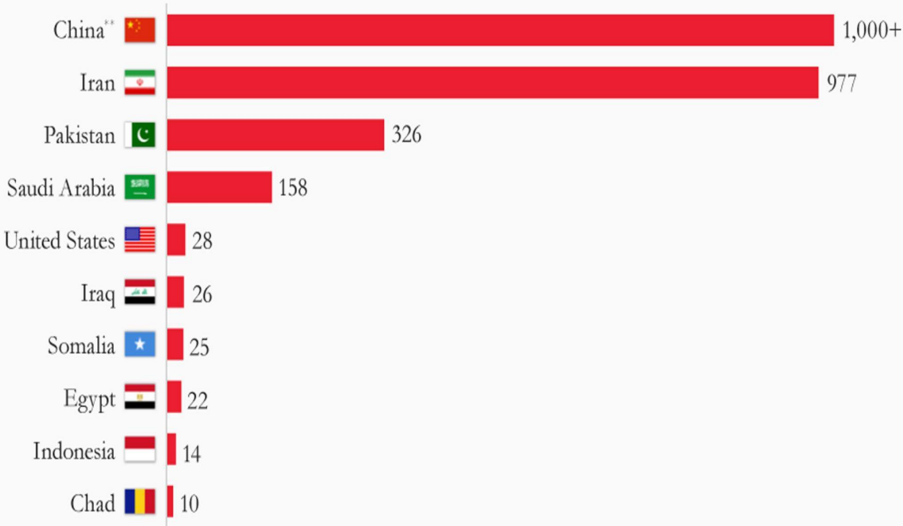

- The death penalty, formerly known as capital punishment, is where a criminal is put to death for their actions.
 - It assumes that human life is sacred, and that the killers who take the lives of their victims forfeit the rights to their own.
- Many countries around the world have outright abolished the death penalty

History:

- In 1972, the U.S Supreme Court declared that the death penalty was cruel and unusual punishment
- Four years later
 - A decision by the high court allowed capital punishment to resume
 - Only by states that wanted it
- Lethal injection is the most used form of execution

- Individuals who don't favor the death penalty do so because of religious beliefs or they feel like it is inhumane

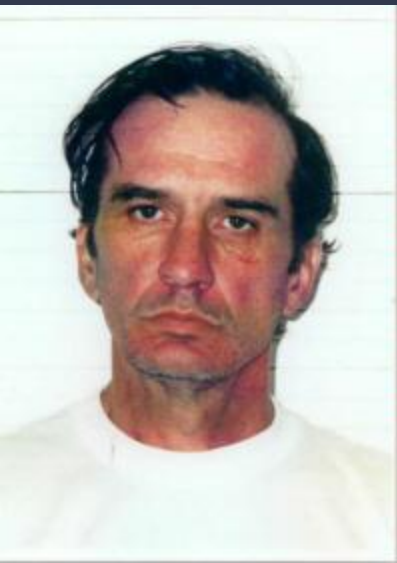
Counter:

Deterrence:

- The death penalty reduces murder
 - “In Texas' largest county, Harris County, the murder rate dropped 73 percent between 1981, the year before Texas resumed executions, 2000” (Pearce 1).
- Life sentences always leave open the possibility of a killer getting a chance to kill again. The death penalty never does

Kenneth Allen McDuff:



- Was first sentenced to death in 1968 for three murders he had committed two years prior.
 - Ended up serving life in prison due to the Supreme Court's ruling against death penalty in 1972
 - He was paroled in 1989
 - Two years after, he murdered a female, and was believed to have killed 4 other females after that.

- If McDuff was sentenced to death, like he should have been, we could have saved 5 innocent people.
